

HSE Leads Thorough Investigation into Lambeth Country Show Ride Malfunction

# Description

The Health and Safety Executive (HSE) has taken charge of investigating a ride malfunction at the Lambeth Country Show. This incident, which took place on June 8, 2024, in Brockwell Park, London, resulted in injuries to four individuals.

#### **Incident Overview**

On the fateful day in June, visitors at Brockwell Park experienced an unexpected calamity. The malfunction of a popular ride caused panic and resulted in four injuries. The immediate response involved emergency services, with the Metropolitan Police spearheading the initial investigation. HSE inspector Stacey Gamwell emphasized their commitment to a thorough investigation, aiming to uncover any breaches of health and safety laws at the time of the incident.

Gamwell stated, â??We will continue to thoroughly investigate what happened and determine whether there were any breaches of health and safety law at the time of this incident. Once we have finished our investigation, a decision will then be made on whether formal enforcement is required in line with our enforcement policy. We remain in contact with those affected by the rideâ??s malfunction and will keep them updated throughout our investigation.â?•

# **Communication with Affected Individuals**

Throughout this process, the HSE is maintaining communication with those affected by the incident. The victims and their families are being kept informed of the investigationâ??s progress. This transparency is crucial in building trust and ensuring that the affected parties are aware of the steps being taken to address the situation.

# **Potential Outcomes**

Once the investigation is complete, the HSE will decide whether formal enforcement action is necessary. This could range from issuing improvement notices to prosecuting those found to be in breach of health and safety laws. Gamwell remarked, â??Our enforcement policy is clear. We aim to



ensure compliance with safety standards. If our investigation reveals that these standards were not met, we will not hesitate to take action.â?•

The outcome of this investigation could have broader implications for the amusement ride industry. It may lead to stricter regulations and enhanced safety protocols, ensuring that such incidents are less likely to occur in the future.
