

The Tragic Incident of Vic Morrow: A Catalyst for Workplace Health and Safety in the Film Industry

# Description

On July 23, 1982, the film industry was shaken by a tragic accident that claimed the lives of actor Vic Morrow and two child actors, Myca Dinh Le and Renee Shin-Yi Chen, during the filming of *Twilight Zone: The Movie*.
